Introduction

Alternative Perspectives and Global Concerns was created in 2008, registered as a not-for-profit corporation in 2014, and was granted Consultative Status by the UN ECOSOC on 12 January 2019. Global concerns are defined by the UN as those that “transcend national boundaries and cannot be resolved by any one country acting alone”. These issues include, but are not limited to, violation of human rights; concerns on democracy; international law and justice; poverty and inequality; climate change; decolonization. Those issues must be responded to with alternative visions beyond the mainstream outlooks.

Alternative approaches are those that go beyond the predominant utilitarian, individual interest-based attitude. They are cross-cultural and set a dialogical bridge between philosophical/ethical arguments and public deliberation. This bridge-making character of alternative perspectives is best manifested in our world’s cultural heritage, which is an antidote to the major threats our common humanity is facing: excessive individualism, unbridled hedonism, and nihilism.

Alternative Perspectives and Global Concerns is committed to:

- Dialogue over common goods, humanization of social relations, and quality of life.
- Exploration of new insights from people with different disciplines.
- Openness to implementation of these insights when faced with global challenges.
- Policy-oriented counselling to both national and international institutions, governmental and non-governmental organizations, and the private sector.

To realize these commitments, AP-GC aims at:

- Advancing a network of engaged and responsible people who are interested in putting their skills and insights into the service of public benefit.
- Publishing and disseminating books and articles which reflect the societal interaction mentioned above.
- Facilitating a global forum to work together with the shared interests to analyze, respond and provide practical solutions for global concerns.
- Providing advisory counselling for organizations in charge of or interested in responding to global concerns.
- Initiating training programs, workshops, and conferences related to alternative perspectives and global concerns.

To undertake its mission, 2019-2022 was a productive period in the life of Alternative Perspectives and Global Concerns. APGC experienced a series of important developments and events giving new directions to the life of the network. Here is a short report on what has been done over the last four years.

Part One: Organizational Developments

1. The constitution of the organization was amended and approved on the 5th of July 2019.
2. The new website of AP-GC was launched in 2020 (ap-gc.net). The website was hacked two times severely. Now, it is operating properly.
3. Now the geographical diversity of the network expands over, Australia, India, Iran, Turkey, Belgium, the Netherlands, Germany, France, Canada, USA, Austria, Colombia, Nigeria, Brazil, Greece, Cameroon, France, Zimbabwe, Kazakhstan, Botswana, and South Africa.

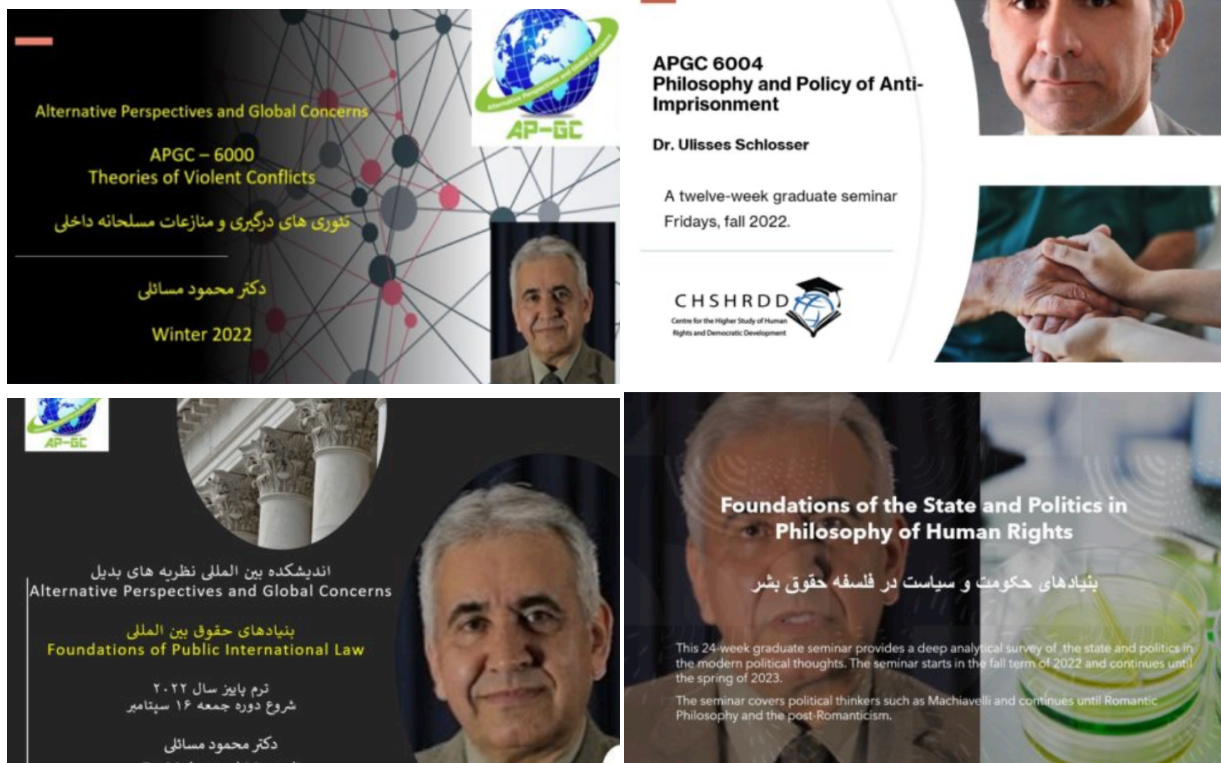

Part Three: Educational Activities

3. A Master's course in 10 weeks entitled "Theories of Violent Conflicts" was initiated and presented in Farsi language for people of Iran, Afghanistan, and Tajikistan. The course by Mahmoud Masaeli started in September 2021 and ended in December of the same year. This not-for-profit initiative absorbed attention of 40 students, seven of them with Ph.D. from Iran and Afghanistan. The textbook for this course is in the process of being completed.
4. "Education, Empowerment, and Human Development" is a one-year initiative prepared for academic and policy-oriented purposes in Afghanistan. This initiative consisted of four master's level courses:
 - An introduction to Development: Concepts, Theories, and Challenges
 - Theories of Development
 - Afghanistan and Challenges of Development in the Condition of Globality
 - Domestic Development in Afghanistan: Perspectives and Challenges.

Unfortunately, with Taliban's re-emergence in Afghanistan this project stays on hold.

5. "International Law in Theory and Practice" is another course initiated for people of Iran, Afghanistan, and Tajikistan. The main purpose of the course is to provide a critical perspective in understanding of the fundamentals of international law. However, the revolt of Iranian people against the Islamic regime, and the continued presence of Taliban in Power, this course was postponed as well. All notes, PowerPoint slides, and instructions and guidelines have already been prepared. The course will be given in March 2023.
